Description:

The wood is the one of the Penrhyn estate woods and is a predominantly broadleaved dingle woodland along the Galedffrwd. The wood is in the process of being purchased by Coetir Mynydd, which is a community group in Mynydd Llandegai with 80+ paid up members. At the western end of the wood, called Parc yr Ynys there is open grassland which was grazed by hill ponies until spring 2003. The wood grades into secondary woodland - beech, oak, sycamore, birch, hazel, holly, willow and in the centre of the wood, there is mature Scots (and Corsican) pine and sweet chestnut which were planted by the Penrhyn Estate in 1902. The western end of the wood is less frequently used by the public.

The eastern section of the wood called Parc yr Ocar, runs along the northern bank of the Galedffrwd. It is dominated by sessile oak which was planted by the estate around 1850 and has plentiful oak and rowan regeneration and an understorey of bilberry. There is a small riparian woodland (oak, willow, alder) at the eastern end of the wood by the dam.

There is archaeological interest within the wood including a clawdd boudary, an old track, possible house platform to the east of the wood and 17th century ochre workings.

Context:

The wood is an important feature in the surrounding landscape especially from the opposite side of the valley from Bethesda, the surrounding villages and from the Carneddi. The wood also very visible from the eastern (Hirdir) road from Mynydd Llandegai to Coed y Parc and Bethesda.

The wood is surrounded by small, semi-improved fields which are rented by the Penrhyn Estate to smallholders. To the south west, the wood is joined by a broadleaved dingle (continuation of Parc yr Ocar).

There is a well used public footpath through the wood which is the main pedestrian thoroughfare from from the village to Bethesda.

The wood is also a popular recreational site (walks, picnics, birdwatching, bilberry picking) which is particularly enjoyed because it is peaceful and has an abundance of wildlife.

History:

The wood is in the process of being purchased by Coetir Mynydd but at present is owned by Penrhyn Estate. In the mid 19th century, the estate planted sessile oak by the Galedffrwd. In 1902, to commemorate Queen Victoria's Diamond Jubilee, the estate planted Scots and Corsican pine and sweet chestnut. The wood has probably not been worked regularly since the second World War because of the difficulties of extracting timber.

There were ochre workings in the wood and a possible medieval house platform.

The woods contain a 6 m high dam constructed in 1847 to supply water to drive a slate mill in the downstream Felin Fawr. Both the dam and water wheel are listed by CADW.
